All arrested persons have an Albanian nationality with 2x being detained and Ix being walked off of the address and warned she is not to be working outside of her permitted occupations.

At around 22:05 all officers departed the address, and the manager was given a Referral Notice to advise that due to illegal working being found a Civil Penalty will be considered by Home Office's Civil Penalty team.
