

# Paper Petition Details

## Parking on Tamar Way

We the undersigned would like to highlight the problems caused by inconsiderable parking by the tenant of house No.31, Tamar Way, Langley, Slough.

We would like to inform you that 75% of the houses on the Parlaunt Park Estate have only rear access to their houses in Tamar Way and Humber Way. In 1962 when the Estate was built this was fine but today in 2012 we are now having the under mentioned problems due to the above tenant at No.31.Tamar Way who parks with no regards to tenants at houses No.23-25-27-29-33. We have tried to discuss the problems with him, but he refuses to move his car from the comer, as he thinks it is his right to park there. The problems he is causing to all the neighbours are as follows:

1. Tenant at No.29 cannot enter or reverse from his garage every time he needs to do so and he has 2 cars, he is forced to park his cars on the road, he is afraid that his insurance company will not cover him if he needs to make a claim in the future as in his policy he mentioned, he parks his cars in the garage.
2. Tenant at No.33 she is disabled and it makes it very difficult for her when someone parks their car on the service road .Bin collectors leave her bin with out taking rubbish, she made 15 calls to complain to Enterprise and they said their lorry could not get passed because of the badly parked car and that's why they could not empty her bin.
3. Tenant at No.23 cannot enter or reverse to his garage on occasions. They have the same bin collection problem as NO.33 and they made more than 75 calls last year to complain.
4. Tenants at 23-25-27-29-33 all have problems with him also.
5. Fire brigades, Ambulances, Large delivery vans, Funerals, Council workers and Bin emptying vehicles are all affected on a regular basis.
6. When his daughter visits there are 4 cars parked at the rear of his house No.31.

Could you please investigate the problem before it escalates into something more serious thanking you.

### Council Response

Thank you for submitting a petition regarding the parking problems you are experiencing on Tamar Way.

After undertaking a site visit, I am happy to place this location on our waiting restrictions request list, with the view to have double yellow lines implemented. The effect of this will

mean that vehicles will be prohibited from parking on both the footway and carriageway at this location, improving access for pedestrians and vehicles and overall road safety. The review of this waiting list is undertaken on an annual basis, and we anticipate the next review being completed later on this year, followed by a formal consultation on our proposals giving the residents the opportunity to make representations. The usual timescale for a scheme to be implemented is between 9-12 months.
